
## FREDERICK DOUGLASS



### FREDERICK DOUGLASS

Frederick Douglass was born a slave in Maryland, around 1818. When he was eight years old, he started working for the Auld family, who were related to his owner. Sophia Auld began teaching Douglass to read, but she stopped when her husband reminded her that it was illegal in Maryland to teach slaves reading. But Douglass still wanted to learn, so he offered food to local boys in return for lessons. Later on, Douglass taught other slaves to read, even though slave owners often broke up their meetings.

As a teenager, Douglass worked on his owner's plantation. During this time, he was treated incredibly harshly. When he was twenty years old, Douglass escaped this terrible life. He pretended to be a free sailor, and traveled to Massachusetts, where many former slaves lived.

In Massachusetts, Douglass went to anti-slavery meetings. In 1841, he talked about his experiences of slavery at such a meeting, and the audience admired his public-speaking skills. After that, he kept on speaking at meetings, which brought him to the attention of prominent abolitionist William Lloyd Garrison, who wrote about Douglass in his anti-slavery publication 'The Liberator'.

As well as giving speeches, Douglass wrote autobiographies describing his own experiences as a slave. The first was in 1845, and was called 'Narrative of the Life of Frederick Douglass, an American slave'. It became a best-seller, but Douglass had to leave America for a while after. This was because he had named his former owner, who might come looking for him. He went to Ireland and spoke about slavery there. He proved so popular that his supporters bought his legal freedom.

After he returned to America as a free man, Douglass set up an anti-slavery newspaper, the North Star. He was also a supporter of women's rights, and took part in the first women's rights convention in New York in 1848. He spoke in favor of pushing for women's right to vote, gaining support for the idea as a result.

During the Civil War, Douglass advised President Abraham Lincoln on the treatment of black soldiers. After the war, he held diplomatic positions in the Dominican Republic and Haiti. Douglass died on February 20, 1895 in Washington D.C.
