

PAT GARRETT

Pat Garrett was born on June 5, 1850 in Cusseta, Alabama, but he grew up on a plantation in Louisiana. He first became a cowboy in Texas. Then he spent a few years hunting buffalo, and he often got into violent fights with other hunters.

Later on, Garrett moved to New Mexico, where he opened and ran a saloon. Then, in 1880, Garrett was appointed deputy sheriff and later sheriff in Lincoln County, New Mexico. One of his jobs was to track down Billy the Kid, who was accused of murdering twenty-one men in the area. Garrett successfully captured Billy the Kid, and put him in jail. But Billy the Kid then escaped and went on the run again.

Garrett searched again for Billy the Kid. He traced him to a house in Fort Sumner. In the middle of the night in July 1881, Garrett went into the house, armed and ready. Billy the Kid met him in the darkness, and Garrett shot Billy the Kid dead.

Although it is not clear exactly what happened that night, word got around that Garrett had shot Billy the Kid without giving a warning. This gave Garrett a bad reputation as a lawman after the killing. Instead, Garrett wrote about a book about the life of Billy the Kid, and this helped make Billy the Kid into a legend.

In 1896, Garrett was called in to help find out what happened to Albert Jennings Fountain, who had disappeared. He was a lawyer who had spoken against men accused of raiding cattle in New Mexico. After the trial, he and his son started off on their journey home, but they were never seen again. Garrett accused two deputy sheriffs of being involved in the disappearance, but they were not found guilty at their trial.

For a time after this, Garrett became friends with Theodore Roosevelt, who made Garrett his customs collector in El Paso, Texas. But he later fell out of favor with Roosevelt because he had a bad temper.

Later on, Garrett was involved in disputes over animals grazing on his land. On February 29, 1908, Garrett was travelling by wagon when he met the man he had been arguing with, Jesse Wayne Brazel. A fight broke out, and Garrett was shot dead.
